### 1.2 Information about the product

Product:

The **VS Multipurpose Nylon Anchor**, according to **ETA – 20/0445**, refer to plastic anchors consisting of a plastic sleeve made of polyamide and an accompanying specific screw galvanised steel of of stainless steel. The plastic sleeve is expanded by screwing in the specific screw which presses the sleeve against the wall of the drilled hole.

### 2.3 Method and range of surveillance

- The notified body followed the current harmonised technical specification EAD 330284-00-0604, which superseded ETAG 020 as of 16 July 2021. The replacement did not

change the method of performance assessment, and therefore verification could be performed.

- The manufacturer has been notified of the changes.
- The following items have been inspected:
  - Possible updating of the FPC documentation including organigram
  - Control of production documentation and production records
  - Control of source materials
  - Control of measuring and testing equipment
  - Product testing and evaluation including respective records
  - Control and maintenance of machinery
  - Control of production process
  - Traceability
  - Control of the finished products, storage, packaging, delivery and marking
  - Surveillance over non-conforming products.

#### **2.4 Results of the surveillance of factory production control**

Results of surveillance are given in record of FPC audit, which was handed over to the manufacturer. Non-conformities were not identified during the surveillance.
